1. Call to Order/Roll Call

Mr. Hess advised that it was recommended to bring more than one choice to the full board meeting.

The Committee continued to review the maps in detail.

Mr. Hunter made the motion to eliminate Maps A, B and D and bring Maps C and E forward to the full county board meeting, and Mr. Fetherling seconded it.

Mr. Hunter repeated his motion for clarity and restated that Map C and E are the choices to move forward. All other Maps, Maps A,B and D would be eliminated.

Mr. Hendrickson stated that he had already done a preliminary run of the ballots and he doesn't expect that any issues will arise.

Mr. Skimerhorn demonstrated to the committee how the software can identify any areas that were not calculated or slivers of areas that are off of the boundary.

Mr. Wheeler advised that there could be another redistricting meeting if need be, but that it more than likely won't be necessary.
